**ORDER PURSUANT TO SECTIONS 366 OF THE
BANKRUPTCY CODE (I) PROHIBITING UTILITY COMPANIES
FROM ALTERING, REFUSING, OR DISCONTINUING SERVICES AND
(II) ESTABLISHING CERTAIN ADEQUATE ASSURANCE PROCEDURES**

Upon the Emergency Motion (the "Motion")¹ of Express Energy Services Operating, LP ("EES") and its affiliated debtors in the above referenced chapter 11 cases, as debtors and debtors in possession (collectively, the "Debtors") for an Order (i) Prohibiting Utility Companies from Altering, Refusing, or Discontinuing Services and (ii) Establishing Certain Adequate Assurance Procedures, all as more fully described in the Motion; and upon consideration of the Declaration of Darron Anderson in Support of the Debtors' Chapter 11 Petitions and First Day Motions; and the Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; and consideration of the Motion and the requested relief being a core proceeding the Court can determine pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Motion and the hearing thereon has been given under the circumstances and that no other or further notice need be provided; and the Court having

determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and upon all of the proceedings had before the Court and after due deliberation and sufficient cause appearing therefor, it is ORDERED that:

1. The Motion is GRANTED to the extent provided herein.
2. As adequate assurance of future payment under section 366 of the Bankruptcy Code, the Debtors shall make a postpetition security deposit equal to one-half of the average monthly bill, calculated based on the historical average over the past five (5) months, (the "New Deposit") to each of the utility companies listed on Exhibit B to this Order (the "Utility Companies") that is not currently holding a prepetition security deposit ("Existing Deposit").
3. As a condition of accepting the New Deposit, at the conclusion of these chapter 11 cases, or on the effective date of any chapter 11 plan, a Utility Company shall promptly remit to the Debtors any unused portion of the New Deposit.
4. Absent a further Court order, all Utility Companies are prohibited from interfering with, disturbing, or discontinuing services to the Debtors on account of these chapter 11 cases and/or any unpaid invoice for prepetition services.
5. Any Utility Company that is not satisfied with the Debtors' proposed adequate assurance (in the form of either the New Deposit or the Existing Deposit), must (i) file a motion with the Court requesting additional adequate assurance and setting forth the basis for such request and (ii) set such motion for hearing no earlier than twenty-five (25) days after the filing of the motion. The Debtors, in their sole discretion, may resolve a motion filed by a Utility Company by agreement and may provide such Utility Company with additional

adequate assurance of payment in addition to the New Deposit or Existing Deposit without further order of the Court.


6. For any Utility Company identified after the Commencement Date, the prohibitions and procedures set forth herein shall be extended to such Utility Company absent a further order of this Court.

7. Nothing in this Order shall be construed (i) to limit, or in any way affect, the Debtors' ability to dispute any request for payment related to Utility Services, (ii) as a waiver by any of the Debtors of their rights to contest any invoice or other claim of a Utility Company under applicable nonbankruptcy law, or (iii) as an admission or concession that any entity is a utility within the meaning of section 366 of the Bankruptcy Code and all rights and defenses of the Debtors are reserved with respect thereto.

8. Bankruptcy Rule 6003 has been satisfied because the relief requested in the Motion is necessary to avoid immediate and irreparable harm to the Debtors.

9. This Court shall retain jurisdiction to hear and determine all matters arising from or related to the implementation, interpretation and/or enforcement of this Order.
